This case came to the Tribunal by way of appeal for implementation of Rights Commissioner Recommendations R-032665-ma-05/DI and R-035128-ma-05-DI.

The determination of the Tribunal was as follows:-

#### **Claimant's Case**

The claimant sought implementation of the Rights Commissioner's decision, R-032665-ma-05/DI where the Rights Commissioner found that that a transfer of undertakings took place that resulted in the claimant having continuity of service. He found that the claimant was constructively dismissed and awarded the sum of  $\notin$ 4,000.

The claimant also sought implementation in relation to R-035128-ma-05/DI where the Rights Commissioner found that the respondent was in breach of Regulation 4 and Regulation 8 of the European Communities (Protection of Employers on Transfer of Undertakings) Regulations (SI 2003/131) and awarded the sum of  $\in 8,000$  and  $\in 1,000$  respectively.

## **Respondent's Case**

The respondent stated that he had not received a copy of the Rights Commissioner's recommendation in time to appeal the claim.

### Determination

The Tribunal orders the implementation of Rights Commissioner Recommendation R-032665-ma-05-DI by which the respondent was to pay them the sum of €4,000 in compensation.

The Tribunal orders the implementation of Rights Commissioner Recommendation R-035128-ma-05-DI by which the respondent was to pay them the sum of  $\in$ 8,000 in compensation in respect of the respondent's breach of Regulation 4 and compensation of  $\in$ 1,000 in respect of the respondent's breach of Regulation 8 of the European Communities (Protection of Employees on Transfer of Undertakings) Regulations (SI 2003/131).
