This case came to the Tribunal by way of appeal for implementation of Rights Commissioner Recommendations R-032658-ma-05/DI and R-035131-ma-05-DI.

The determination of the Tribunal was as follows:-

Claimant's Case

The claimant sought implementation of the Rights Commissioner's decision, R-032658-ma-05/DI where the Rights Commissioner found that a transfer of undertakings took place that resulted in the claimant having continuity of service. He found that the claimant was unfairly dismissed and awarded the sum of $\mathfrak{S}_{3,500}$.

The claimant also sought implementation in relation to R-035131-ma-05/DI where the Rights Commissioner found that the respondent was in breach of Regulation 4 and Regulation 8 of the European Communities (Protection of Employers on Transfer of Undertakings) Regulations (SI 2003/131) and awarded the sum of 64,300 and 600 respectively.

Respondent's Case

The respondent stated that he had not received a copy of the Rights Commissioner's recommendation in time to appeal the claim.

Determination

The Tribunal orders the implementation of Rights Commissioner Recommendation R-032658-ma-05-DI by which the respondent was to pay them the sum of $\in 3,500$ in compensation.

The Tribunal orders the implementation of Rights Commissioner Recommendation R-035131-ma-05-DI by which the respondent was to pay them the sum of €4,300 in compensation in respect of the respondent's breach of Regulation 4 and compensation of €600 in respect of the respondent's breach of Regulation 8 of the European Communities (Protection of Employees on Transfer of Undertakings) Regulations (SI 2003/131).
