The determination of the Tribunal was as follows:

The Tribunal is satisfied that the respondent was properly notified of this hearing. Neither the company nor a representative on its behalf appeared for this hearing. According to the claimant the respondent went into liquidation on 7 September 2006.

Based on the uncontradicated evidence and submissions from the claimant the Tribunal finds that the claimant was dismissed, without due notice, by way of redundancy. He is therefore awarded a statutory redundancy sum under the Redundancy Payments Acts, 1967 to 2003 based on the following:

Date of Birth: 13 March 1947 Date of Commencement: 1 March 1991 Date of Termination: 29 March 2006

Gross Weekly Wage: €480.00

The appeal under the Minimum Notice and Terms of Employment Acts, 1973 to 2001 is allowed and the appellant is awarded €3360.00 as compensation for seven weeks' outstanding notice.

Since the claim under the Unfair Dismissals Acts, 1977 to 2001 is mutually exclusive with the Redundancy Payments Acts, 1967 to 2003, it follows that this claim is dismissed.
