The determination of the Tribunal is as follows:

Preliminary Issues:

Solicitors representing a portion of the appellants made known at the outset the exact appellants they were representing for the Tribunal.

The firm of auditors and accountants confirmed that the respondents "a-d" above were actually "c" and the record could be amended to show that fact. This company "c" was placed into voluntary liquidation on the 26th June 2007 and the above named were appointed as liquidator to this company from that date. At the outset, the solicitors named above for respondents "a-d" above were confirmed as no longer on record.

Solicitors representing Respondent "e" above made a submission to the Tribunal that they had no responsibility for the employment of the above named appellants and requested that their company be withdrawn from the proceedings. This was accepted by all the parties.

All parties agreed that redundancy in this case was not in dispute. Claims under the Minimum Notice and Terms of Employment Acts, 1973 to 2001 and Organisation of Working Time Act, 1997 were included by consent of all parties at the hearing. Two appellants who had proceedings activated at the Rights Commissioners agreed to withdraw those proceedings based on the fact that the Tribunal was to determine the claims at this hearing.

All parties agreed to accept that the figures supplied by the liquidator were to be the final figures that the Tribunal would base its determination on, should the appellants be successful in their appeals.

The liquidator agreed that a Transfer of Undertakings, in accordance with the relevant legislation, occurred between respondent "e" and respondent "c" on the 14th September 1999, and all previousservice would be applicable for the purposes of reckonable service for the appeals of relevantappellants.

Determination:

The Tribunal determines that all appellants were made redundant by virtue of the fact that the respondent "c" terminated their contracts. The Tribunal was also cognisant of the fact that the liquidator appointed to the respondent was in agreement with this fact.

The appellants agreed that the claims made under the Unfair Dismissals Acts, 1977 to 2001, were withdrawn. Accordingly, the Tribunal dismiss these claims.

The Tribunal determines that the appellants did not receive their statutory holiday entitlements, including payment for Bank Holidays, and therefore awards the appellants 18 months (being 43.5 days' pay) under the Organisation of Working Time Act, 1997, in line with the details of gross pay set out in the Schedule below.

The Tribunal determines that the majority of the appellants are entitled to remuneration under the Minimum Notice and Terms of Employment Acts, 1973 to 2001, and award them their statutory minimum notice in line with their entitlements detailed in the Schedule below. It should be noted that appellants 1,2, 4,6,9 & 12 all received notice equal to or in excess of their statutory entitlement and their claims under these Acts must fail
