The decision of the Tribunal was as follows:-

Appellants' case

In sworn evidence, the Tribunal were told that the appellants, who are wife and husband, commenced employment in April 2002 and May 2002 respectively and their employment ended in November 2006. Their daily start and finish times varied but they both worked the same hours and did the same type of work. In November 2006, the appellants returned to their own country for a holiday and when they returned to Ireland, they discovered that their employer had closed down in December.

Both appellants were on work permits, which were due to expire in March 2007. It was confirmed

that neither received payment in respect of redundancy or minimum notice. The original P60 forms of both appellants for the years 2002, 2003, 2004 and 2005 were opened to the Tribunal.

Respondent's case

There was no appearance by or representation on behalf of the respondents. The Tribunal is satisfied that notification of the hearing was properly sent to the respondents.

Determination

Based on the uncontested evidence, the Tribunal is satisfied that a redundancy situation existed. The Tribunal therefore finds that the appeals under the Redundancy Payments Acts, 1967 to 2003 succeed and the appellants are awarded a redundancy lump sum, which is to be calculated on the basis of the following criteria:

This award is made subject to the appellants having been in insurable employment under the Social Welfare Acts during the relevant period.

The Tribunal is satisfied on the basis of the evidence adduced that employment terminated without notice. Loss having being established, the Tribunal therefore finds that the appeals under the Minimum Notice and Terms of Employment Acts, 1973 to 2001 succeed and awards two weeks payment in lieu of notice in respect of appellant A in the amount of \in 740.00 and appellant B in the amount of \in 800.00 respectively.
