The decision of the Tribunal was as follows:-	

At the outset the claims under the Organisation of Working Time Act, 1997 and the Minimum Notice and Terms of Employment Acts, 1973 to 2001 were withdrawn by the claimant's legal representative.

Both employees had been employed by the respondent XXXX since 1999. On 8th March 2008 the business was transferred to XXXX. On 12th March 2008 the employees were told that XXXX had purchased all of the assets of the company and both employees were assured that they were covered under the European Communities (Protection of Employees on Transfer of Undertakings) Regulations 2003. Their employment was terminated on 18th April 2008 when the respondent advised the employees that they would be re-locating premises and would no longer have a base in Cork. XXXX became a UK incorporated company and changed its name to XXXX on 2nd June 2008.

A Liquidator was appointed to XXXX ("the company") on 3rd April 2008. In correspondence from the Liquidator he stated that the sale of the company was completed prior to the Liquidation.

The legal representative asked that any order of the Tribunal be made against XXXX.

Determination:

The Tribunal is satisfied that in the case of both employees their employment ended by reason of redundancy and they are entitled to a redundancy lump sum under the Redundancy Payments Acts, 1967 to 2003 based on the following:

The first named employee

3rd October 1964 Date of Birth 4th April 1999 Date employment commenced Date employment ended 23rd April 2008 Gross weekly salary €350

The second named employee

27th October 1961 Date of Birth 4th April 1999 Date employment commenced 18th April 2008 Date employment ended €285

Gross weekly salary

Please note that these awards are being made subject to the employees having been in insurable employment under the Social Welfare Acts during the relevant period.
