The decision of the Tribunal was as follows:-

Kevin O'Gara, Solicitor appeared on behalf of Ralfar Limited. However no witnesses appeared on behalf of this respondent. There was no appearance by or on behalf of the other respondent.

## Appellant's case

The appellant stated that her employment with the respondents commenced on 6<sup>th</sup> March 2006 and ended on 7<sup>th</sup> March 2009 and that her gross pay was €440.00 gross per week. The representative of the respondent agreed that this was the correct gross weekly pay of the appellant at the date of

cessation.

On 7<sup>th</sup> March 2009 the appellant was informed that she was being let go with immediate effect. She was not paid wages in lieu of notice. At the time of cessation of employment the appellant was due four weeks holidays for which she has not been paid. The appellant has not received any redundancy lump sum payment to date.

## **Determination**

Having considered the uncontested evidence of the appellant the Tribunal awards the appellant a redundancy lump sum under the Redundancy Payments Acts, 1967 to 2007 based on the following criteria.

DOB	12 <sup>th</sup> June 1982
Commencement Date	6 <sup>th</sup> March 2006
Dismissal Notice Received	N/A
Termination date	7 <sup>th</sup> March 2009
Non Reckonable Service	N/A
Gross pay	€440.00

This award is made subject to the appellant having been in insurable employment, during the relevant period, in accordance with the Social Welfare Acts.

The Tribunal awards the appellant €1,760.00, being four weeks wages, in lieu of holidays under the Organisation of Working Time Act, 1997.

The Tribunal awards the appellant €880.00, being two weeks wages, under the Minimum Notice and Terms of Employment Acts, 1973 to 2005.
