### **Preliminary Issue**

This claim was lodged outside of the six-month time limit from the date of termination of employment imposed by the Unfair Dismissals Acts, 1977 to 2007. The time limit could be extended to 12 months if there were exceptional circumstances as described by the said Acts to cause this delay. This claim was lodged outside of the 12-month time limit. The Tribunal, therefore, rules that it does not have jurisdiction to hear this case and the appeal necessarily fails.

The determination of the Tribunal was as follows: -

# **Claimant's Case**

The Claimant commenced employment with the Respondent, a Construction Company, in September 2005 after he completed The Safe Pass Course. The Claimant was out sick in 2006 for a few weeks due to his high Blood Pressure. The Claimant had heard rumours on the site that Staff were being let go. The Respondent informed him that he was being 'fired' due to his high Blood Pressure. The Respondent informed him that if any further work came up he would contact him. The Claimant did not receive a Contract of Employment, terms of conditions of employment or Payslips.

The Claimant did not receive any Notice or pay in lieu of Notice. The Claimant took two weeks holidays from 2007 to his termination in March 2008 and one week in 2006. The Claimant has not gained employment since his termination and is now in receipt of Social Welfare Illness Benefit.

# **Respondent's Case**

The Claimant approached the Respondent and informed him he could no longer work due to his high Blood Pressure. The Claimant was paid for all the Annual Leave he took. The site did not open on Bank Holidays; the Claimant was paid all his Bank Holiday entitlements.

# Determination

The Tribunal find that the claim under the Minimum Notice and Terms of Employment Acts, 1973-2005 fails, as the Claimant did not adequately prove his case.

The Tribunal find that the claim under the Organisation of Working Time Act, 1997 fails because it is out of time pursuant to Section 27 of the said Act.
