The determination of the Tribunal was as follows:

Determination:

It being established that the first three named appellants had received their entitlements under the Minimum Notice and Terms of Employment Acts those appeals were withdrawn. The appeals of the first three named appellants under the Redundancy Payments Acts were conceded. The appeals of the fourth and fifth appellants under the Redundancy Payments Acts were conceded on the basis that, whilst the fourth named appellant was employed to cover the fifth named appellant's duties, when she became unable to perform her duties because of illness, in February 2007 her employment was not terminated before the other appellants were dismissed when the respondent ceased trading. The appeals of the fourth and fifth named appellants under the Minimum Notice and Terms of Employment Acts were also conceded. Accordingly, the Tribunal is satisfied that the appellants are entitled to lump sum payments under the Redundancy Payments Acts, 1967 to 2007as set out in the following schedule. The Tribunal further awards the amounts shown in the schedule under the Minimum Notice and Terms of Employment Acts, 1973 to 2005
