#### **Background:**

The appellant confirmed his commencement and termination dates and his gross weekly wage. The owner told him on December 11<sup>th</sup> 2008 that there was no more work for him. He received his P45 two days later.

The owner of the respondent company stated that he had told his staff that there was no more work for them at that time. He gave the appellant his P45 in order he could claim social welfare benefit.

#### **Determination:**

The Tribunal after considering all the evidence concluded that the issuing by the respondent of the P45 to the appellant constituted a dismissal of the employee and as there was no more work for him at the time of his dismissal it was by reason of redundancy.
