The determination of the Tribunal was as follows:-

Background:

Both claimants gave evidence. No witnesses where present to give sworn evidence on behalf of the respondent. The respondent's Accountant was present to give a submission on behalf of the respondent company. The respondent's position was that the claimants were let go on July 17 2009 and were rehired as sub-contractors from 1 August 2009 to 19 November 2009. RDCDC forms were sent to both claimants with their P45 in December 2009. The second named claimant signed both documents, the first named claimant did not.

Both claimants stated they had continued in employment with the respondent until 19 November

2009 when they ceased to receive calls to turn up for work.

Determination:

Having carefully considered the evidence and submissions adduced by all parties in this case, the Tribunal finds that the appeals under the Redundancy Payments Acts, 1967 to 2007 succeed and awards the appellants a redundancy lump sum, which is to be calculated on the basis of the following criteria:
