The decision of the Tribunal was as follows:-

**Determination:**

Of the 11 named claimants in this case only the fifth and ninth named claimants were in attendance on the day of the hearing.

The Tribunal is satisfied that all claimants were properly notified of this hearing. As there was no appearance by or on behalf of the other nine named claimants the Tribunal dismisses their claims under the Minimum Notice and Terms of Employment Acts, 1973 to 2005 for failure of want of prosecution.

Based of the evidence the Tribunal is satisfied that the fifth and ninth named claimants did not receive their minimum notice entitlement.

Accordingly, the Tribunal awards the fifth named claimant the sum of € 181.38, this being the equivalent of one weeks pay, under the Minimum Notice and Terms of Employment Acts, 1973 to 2005.

The Tribunal awards the ninth named claimant the sum of € 228.00, this being the equivalent of one weeks pay, under the Minimum Notice and Terms of Employment Acts, 1973 to 2005.
