The director of the former company confirmed that the appellants' employment had terminated by reason of redundancy. The director consented to the amending of the form T1A to reflect the correct employer.

Determination:

The Tribunal finds that the appellants are entitled to a redundancy lump sum payment under the under the Redundancy Payments Acts, 1967 to 2007, based on the following criteria:

The Tribunal also finds that Appellant A is entitled to the sum of €1,326.00 (being the equivalent of two weeks' gross pay) under the Minimum Notice and Terms of Employment Acts, 1973 to 2005.
