Determination

The Tribunal is satisfied that the respondent was properly on notice of this hearing, but neither they, nor a representative on their behalf attended the hearing. Based on the uncontested evidence of the appellant the Tribunal find that the appeal under the Redundancy Payments Acts, 1967 to 2007 succeeds and awards the appellant a redundancy lump sum based on the following;

Date of Birth	27 th July 1978
Employment commenced	1 st November 2001
Employment ended	3 rd November 2009
Gross weekly pay	€680.62

This award is made subject to the appellant having been in insurable employment under the Social Welfare Acts during the relevant period.

Please note there is a statutory ceiling of €600.00 for all payments from the Social Insurance Fund.

The Tribunal further awards €2722.48, being four weeks' pay, under the Minimum Notice and Terms of Employment Acts, 1973 to 2005.
