Determination

The Tribunal is satisfied that all parties were properly notified of the hearing. The Tribunal noted that the second named respondent company is dissolved since the 23 September 2012. As there was no appearance by or on behalf of the two named respondents and based on the uncontested evidence of the four appellants the Tribunal finds that they were dismissed by reason of redundancy.
