The Tribunal is satisfied that the receiver was duly notified of the hearing.

Representation for the claimants informed the Tribunal that the claims under the Unfair Dismissals Acts, 1977 to 2007 and the Organisation of Working Time Act, 1997 were

withdrawn.

#### **Determination:**

Based on the claimants' uncontested evidence the Tribunal finds that they are entitled to a lump sum payment under the Redundancy Payments Acts, 1967 to 2007, based on the following criteria:
